I write in connection with my letters to the court dated 19th June 2006 and 22nd June 2006, and also to the formal complaint submitted to the Law Society dated 19th June 2006.

Further to the orders set by Master Rose in the directions hearing on the 14th June 2006, please be advised that I received the defendants supporting evidence for their summary judgement application later than was ordered, on Saturday 24th June 2006.

In the accompanying letter to the defendants evidence, the defendants solicitors claim that the defendants key witness has apparently forgotten to sign his statement and is now also out of the country. Interestingly, I am due to file and serve a statement to accompany my application for permission to commence committal proceedings against their client this coming Wednesday the 28th June 2006 and I must say that given the fact that the defendants solicitors wrote to me last week requesting that I withdraw this application, I find this latest administrative error on their part slightly hard to accept as being a genuine one.

Due to their recent request that I withdraw my application for committal, it appears as though the defendant is somewhat apprehensive as to the content of the awaited statement and I strongly believe that they are waiting to read my statement before they verify their witness statement with a signature. I am therefore seeking the courts permission to be able to postpone the filing and service of my statement that will accompany my application for permission to commence committal proceedings, until I am in receipt of both of the defendants signed witness statements that they will rely upon as supporting evidence for their summary judgement application.

As I have recently reported the defendants solicitors to the Law Society, please be advised that a copy of this letter has been forwarded to them for their files. A copy of the defendants letter dated 22nd June is attached with this fax for your information.
